About RISE Project

RISE PROJECT was established in January 2012 by a group of Romanian investigative journalists, visual artists and programmers.

RISE PROJECT is an investigative journalism not-for -profit organization that uses advanced investigative techniques and technology to generate high quality investigative reporting.

At RISE PROJECT we generate investigative stories and visual databases. We educate other journalists and the public at large in researching complex corporate structures used by organized crime and corrupt officials.

RISE PROJECT is affiliated to the Organized Crime and Corruption Reporting Project / OCCRP (www.occrp.org), the Investigative Dashboard /ID (www.investigativedashboard.org) and the Global Investigative Journalism Network (www.gijn.org).

AIM

To investigate organized crime and corruption in Romania and the region.

HOW WE WORK

We follow the money across borders. We combine footwork with advanced investigative techniques and with data analysis to access hard to get records. We investigate the hidden connections between organized crime, politics and business and we visualize them.

ACROSS BORDERS

We follow and expose organized crime networks across national boundaries. In 2012, our investigations took us from Romania to the Czech Republic, Moldova, Iceland, Turkey, Egypt, Sweden, West Africa and other countries.

Financial Information

Most of the investigative work for RISE PROJECT is done on voluntary, no pay, basis. RISE members use their skills and donate their time to produce some of the finest investigative reporting.

In September 2012 RISE PROJECT received a \$5150 grant from the Embassy of the United States of America in Romania to produce a "Follow the Money" Handbook for Romania and Moldova. The handbook will assist investigative journalists in tracking down the money across borders and in mastering advanced investigative reporting techniques. It includes thorough guidelines and tutorials on how to dig for company records in Romania and Moldova and will be launched at the end of February 2013.

RISE PROJECT is also a partner in the Visual Investigative Scenarios (VIS) project financed by the International Press Institute (IPI) and Google Inc.

The project duration is 12 months: June 2012 - June 2013, and the total budget is 71,100 Euro. RISE PROJECT receives 21,600 Euro for the research, coordination and communication activities within the project. The other project partners are Journalism Development Network (JDN) and Quickdata. Visual Investigative Scenarios (VIS) will provide a free online tool for journalists to visualize their investigations without the need of any technical or design skills. The VIS online platform will be launched in July 2013.






which we represented on our website through infographics and visualizations

At RISE PROJECT we make use of databases from all over the world, of the latest technology and of cross-border investigative reporting networks to produce investigations that uncover regional and global organized crime and corruption.

For example, in 2012 we cooperated with journalists in Iceland and Sweden to document the connections between a fugitive Romanian stockbroker, a multinational company and a minister in the Romanian government - in "The Ericsson Affair".

Between February and December 2012 we produced 15 major investigative series (e.g. "The Ericsson Affair", "The Market Sultans", "Hidden Interests in the Media" etc.) containing a total of 61 Stories.

We covered people, companies, law suits and connections at a local and at a cross-border level involving many countries: Romania, Moldova, Czech Republic, Ukraine, Russia, Bulgaria, Turkey, Austria, United Kingdom, Sweden, Iceland, Panama, Cyprus, Switzerland, Spain, Egypt, Siria etc.



RISE PROJECT is not only about investigative techniques. We collaborate with programmers, designers, activists and researchers to enhance journalism education, develop tools and contribute to data and information transparency. We keep the pace with new technologies, new data sources and ever-changing information by focusing on three key areas in investigative journalism: Education, Innovation and Research.



"Follow the Money" Handbook

We are editing a handbook to help investigative journalists follow the money across borders and master the techniques of data journalism. The handbook includes thorough guidelines and tutorials on how to dig for company records in Romania and Moldova and will be launched in February 2013. The project is funded by the Embassy of the United States of America in Romania. In 2013 we are planning to prepare new handbooks focused on other Eastern European countries.



Visual Investigative Scenarios (VIS)

In June 2012 we started to develop a free online tool for journalists to visualize their investigations without the need of any technical or design skills. One of the winners of the "2012 News Innovation" Contest" launched by the International Press Institute (IPI) and sponsored by Google Inc., Visual Investigative Scenarios (VIS) will provide investigative journalists with exportable, customizable, dynamic, html5 visualization templates. The project is aimed at journalists who investigate organized crime and corruption and who follow money across borders. VIS will provide a website with several categories of professionally designed visualization templates matching different types of investigations and related data. VIS is a common project of RISE Project, the Journalism Development Network and Quickdata. The VIS online platform will be launched in July 2013.



Media Ownership Project

We are researching and indexing ownership data for the major TV, radio, print and on-line media in Romania. This research is part of a regional Media Ownership Project covering all the Eastern European countries. The data will be indexed and visualized online in early 2013. The project is coordinated by the Organized Crime and Corruption Reporting Project (OCCRP) and funded by the Open Society Foundations (OSF) and National Endowment for Democracy (NED).



For 2013 we are planning to extend the activities of RISE PROJECT in three areas:

- 1 Training courses for investigative journalists
- Video-Tutorials on how to follow the money across borders
- 3 Audio-video materials to accompany our investigative stories
